4. Details of our assessment

This report details the site visit made on the 20th November 2020 to United Recycling Aggregates LTD, permit reference number EPR-PB3230AQ.

Officers Alex BOWDER and Greg GARDNER attended the United Recycling Aggregates LTD site at Birdport Docks, Newport, NP19 4RE for a routine site inspection at 10:30am where we met with Adrian DAVIES (Delegated TCM) and Emma THOMAS (Environmental Manager). The weather was wet and cold which it had also been the previous day.

To remind the company following each visit Natural Resources Wales will produce a Compliance Assessment Report (CAR) detailing our comments from the inspection. If we substantiate reasonably foreseeable risks or actual impact to the environment, we can breach the business against your permit conditions which can affect your site banding and annual subsistence fees; this is scored on a Category 1 - 4 basis:

- 1 - Major, serious persistent and/or extensive impact on the environment/people/property
- 2 – Significant impact on effect on the environment/people/property
- 3 – Minor impact or effect on the environment/people/property
- 4 – A non-compliance which has no potential environmental effect

GENERAL OBSERVATIONS

United Recycling Aggregates LTD operate under a Tier 2 Bespoke environmental permit

based on standard rule set SR2010_No12. The site is primarily used as a storage area for small amounts waste material such as granulated tarmac and aggregates. At the time of the visit there were two stockpiles of aggregate material (as seen in photos 1 and 2) with the ground under foot consisting of loose tarmac gravel. There is no treatment of material on site and there is no intention of treatment going forward for the future.
