On the 3rd April 2018 Natural Resources Wales received a report (WIRS reference 1801793) reporting concerns regarding the water quality of the Afon Dulas downstream of Bryn Posteg Landfill site.

E2 - Emissions to water

Environment Officer Aled Rees attended the area and investigation concluded that there was evidence of significantly turbid water discharging from the outfall. A formal sample of this discharge was taken. The location of this outfall was SN96453 81891, which is an outfall consisting only of surface water from the permitted site (emission reference P2)

The formal sample of the discharge confirmed a significant breach of permit condition limits.

Upstream and Downstream samples of the receiving watercourse were taken on the day to assess the impact upon the receiving watercourse, results concluded a significant impact on the quality of the Afon Dulas extending at least 1km downstream

Table S3.3 within the permit stipulates permit limits that should not be exceeded.

Suspended solids are over 3 times the permit limits, whilst Ammonia is over 282 times the permitted limit and BOD over 5 times the permit limit. As a result the operator has breached limits stipulated in the permit. It must be noted that there is clearly a significant impact on the receiving watercourse, whilst ammonia concentration in the receiving watercourse upstream of where P2 enters were around 0.054mg/l, samples taken directly downstream of P2 show a result of 23.3 mg/l and samples taken from the receiving watercourse approximately 1km downstream show a high result of 7.76. There is also clear impact on BOD and suspended solids from your discharge noted on the receiving watercourse for at least 1km downstream.

The Afon Dulas downstream of the tributary is classified under Water Framework Directive standards as high quality for ammonia and overall meets good quality status. For example, we would expect this stretch of river to have less than 0.3 mg/l of ammonia. Discharge into the Dulas catchment of the poor quality noted above could significantly affect the overall quality of this part of the Afon Dulas catchment.

Natural Resources Wales informed the site of this pollution incident and the investigations Natural Resources Wales were undertaking and requested that the site investigate this pollution as a matter of urgency, and feedback findings to NRW including details of measures taken to stop this pollution.

Due to the significant breach in limits of table S3.3 and a significant risk of pollution a CCS 2 score has been noted.
