Natural Resources Wales has received evidence of the WAMITAB qualification for David Evans as the Technically Competent Manager for the Gwynedd Council Ffridd Rasus Waste Transfer Station

permit. EPR:YB3897TF with thanks.

No issues have been noted.

Incorrectly Completed Waste Transfer Notes

It has come to the attention of NRW that waste has been accepted at Ffridd Rasus CA site under the attached waste transfer note. The following errors are present:

1) There is no tonnage listed on each note and so I cannot measure how much waste has been imported into the site.

2) The SIC code is not complete on all notes.

3) Not all notes are signed.

4) The hierarchy statement is not complete for each note.

This highlights that staff had not been trained sufficiently to allow them to correctly fill out waste acceptance paperwork correctly.

This is a **category 3** permit breach with respect to permit condition **1.1.1(a) “The operator shall manage and operate the activities using sufficient competent persons and resources”**.

Action: Provide toolbox talks and staff training to ensure that paperwork is filled out correctly in future.
