## 4. Details of our assessment

On Thursday the 12th of November 2020 waste regulation officers Boguslaw Pierzchala and Steve White attended Delyn Metals, Point Of Ayr Treatment Facility. This was a follow-up visit after the inspection on the 15<sup>th</sup> of October 2020.

This was an announced inspection due to the current Covid 19 restrictions to ensure safety of all people involved.

The officers were met and accompanied through the inspection by Jeff Mound, owner, and Stuart Butterworth, site manager/TCM.

### Security

The site is enclosed by a fence and there's also a lockable gate leading onto the site. There are a number of CCTV cameras as well as a night security officer on site.

### Management system and operating procedures

A large number of off-cuts was seen, lined on both sides of the path leading onto the site and also in the first fenced yard as you enter the site.

Mr Mound stated that around 20 tonnes of off-cuts are being brought to the site from Kingspan (Greenfield) a month; The off-cuts are being used to make corrugated roof sheets using a cold-pressing machine (see photo).



Mr Butterworth confirmed that at the moment more material is being brought to the site that they can reprocess, and the extra material is being stored on site. The operations started earlier this year.

This activity will need either an exemption or a permit variation registered in order to continue. This has been discussed with both, the owner, and the site manager. Separate guidance will be sent regarding this operation.

The storage of metal and the site activities were also discussed. Mr Butterworth stated that the main site in Gwespyr is above its storage limit, therefore new deliveries of metal are being diverted to the Point of Ayr site. The acceptance of waste metal on site constitutes the site being operational and NRW needs to be made aware of this change.

A large amount of metal waste was seen on site; this consists of old waste that has been on site for some time and waste that is being brought into the site for storage.

As Natural Resources Wales has not been made aware of the site becoming operational it constitutes a breach of the permit condition as outlined below.

#### **Reporting and notification**

Condition 1.10.2 of the site permit states that in the event that the site ceases receiving waste for longer than 21 days then within 7 days following the elapse of that time, The Licence Holder shall inform the Agency in writing of the date of cessation and of the planned date of recommencement. In the event that the Licence Holder intends that the site shall recommence receiving wastes sooner than the notified date then they shall give the Agency not less than 7 days prior notice in writing.

Condition 7.2.2 of your permit refers to waste returns. These quarterly returns should be submitted to NRW within 1 month of the end of that quarter. During times when the site is not operational, it is still required to submit waste returns and mark it as "NIL" (these have been submitted in the period between the visit and the completion of the CAR form for the visit but have not yet been logged on the site file).

The breach relating to waste returns was raised within the previous CAR form and was consolidated with the breach of condition 1.10.2 above. As such the score is logged as an 'ongoing' non-compliance and will not be duplicated.
