4. Details of our assessment

The Waste Minimisation Review and the Water Use Efficiency Review were received on 2nd December 2020.

Both reports are accepted.

These reports are due for submission every four years. **They will both be due again by 2nd December 2024.**

Water Use Efficiency Review

Water use per 1000 parts was greater than in 2018 but less than in 2017. Effluent discharged to sewer per 1000 parts was the lowest since 2016.

All relevant water efficiency measures are BAT compliant.

Waste Minimisation Review

The report contains a very clear diagram, illustrating the origin of each waste stream and its disposal route.

Each waste stream has been reviewed, compared with the amount generated in the previous year and improvements and alternatives considered.

Incineration, at the moment, is generally considered to be an expensive and unnecessary option.

Disposal costs will be reviewed and better separation of some wastes has been proposed. Collections of some wastes will only be on an "as needs" basis to reduce transport costs and the associated CO₂ emissions. Waste minimisation for some wastes and further recycling options for plastic containers will be investigated.

It may be possible to use waste sulphuric acid in the effluent treatment process, rather than sending it for chemical disposal and it may also be possible to recycle waste zinc plating solution.

The drumbrake line has been closed, so no waste will be generated by these processes in the future.

There may be a short-term increase in waste generation due to the disposal of associated equipment and chemicals.

Both reviews clearly describe measures taken, or proposed, to minimise water use and waste generation. ZF should maintain these reviews, in association with the requirements of ISO14001, to continually improve their resource management.
