**Compliance Assessment Report – Unit 17, Tremorfa Industrial Estate (EPR-UP3295FU)**

Officer David WARWICK-BROWN visited Unit 17 (Project Black Recycling) at 12:00-12:15 on 01/12/2020 for a

routine site inspection and met with George Harvey (TCM) & Howard Oakes (Recycling Manager). The weather was dry and overcast during the inspection.

This site has been mothballed temporarily due to COVID-19, so was empty and non-operational at the time of inspection. Prichard's have been directing their focus to their other sites (Project Red and Project Yellow) in the meantime and will inform NRW if or when Unit 17 begins accepting waste again.

The Officer was informed that the TCM's WAMITAB continuing competency certificate is up to date. However, NRW do not currently have a copy of this document on file.
