4. Details of our assessment

Compliance Assessment Report – Atlantic Auto Salvage Ltd (EPR-BB3099FH)

Officer David WARWICK-BROWN visited Atlantic Auto Salvage Ltd at 11:20-11:35 on 03/12/2020 for an

introductory inspection of this new permit (issued 22nd January 2019). The Officer met with Sean Edwards, an acquaintance of James Richards (Director), as Mr Richards was unable to attend the meeting on this occasion. The weather was dry and overcast at the time of the inspection. One minor breach has been scored following this inspection, relating to your waste returns, as explained below.

Inspection

The site was a very well organised, clean and tidy ELV facility; a small-scale operation within a small unit. The Officer walked around the perimeter of the unit and took numerous photos while inspecting the site. The whole operation was contained within a building, which had an impermeable surface and a sealed drainage system as required by the permit.

Wastes were all being stored in individual compartments as required. There was no evidence of any spillages from the site's operations. The Site Officer spoke to James Richards on the phone following the inspection, who confirmed that all waste materials are sent to Sims Metals Cardiff.

All paperwork was available at the site as required. However, the current WAMITAB certificate for Technically Competent Manager (TCM) Gareth Danter-Hill on file expired in February 2020.

Action: Please send NRW a copy of the relevant continuing competency WAMITAB certificate. Otherwise, please send NRW a confirmation of a test booking with WAMITAB to obtain this certification.

Compliance

G4 – reporting & notification to NRW – permit condition 6.1.2 – category 4 breach:

Permit condition 4.2.2 within your permit (SR2011 No3) states that 'Within one month of the end of each year, the operator shall submit to Natural Resources Wales using the form made available for the purpose, the information specified on the form relating to the site and the waste accepted and removed from it during the previous year'. The deadline for the submission of your waste returns was due to be received by the end of January 2020. This same submission is expected within one month prior to the end of January 2021. A **category 4 breach** is being scored for this non-compliance with the permit.

Action: Please submit your waste returns to NRW as required.
