4. Details of our assessment

In an email on the 19th October to myself and as confirmed during the site inspection on the 10th November, you have recently started processing refrigerant waste in larger volumes, and have set up an analysis, sorting and recovery bay inside the building which is outside of the site boundary of the permitted facility.

Undertaking this activity at present is a breach under Condition 2.2.1 of Permit MP3531MD which states that:

The activities shall not extend beyond the site, being the land shown edged in red on the site plan at schedule 2 of this permit.

This therefore results in a CCS 4 score as a non-compliance which has no environmental impact.

ACTION: As discussed on site you will need to apply for a variation to your permit to extend the boundary of the permitted facility to include this activity. You can find all the relevant forms on our website. Please submit this variation by the 29th Jan 2021 - if you have any concerns with this date please contact me.

Alongside the boundary variation, you also advised you would like to add additional waste codes to those listed on your permit. This would also need to be included in your permit variation. As advised on site when completing the variation if you tick 'consolidated permit' this will ensure the new variation includes all the latest permit conditions.

The site inspection on the 10th November 2020 did not result in any other non-compliances or concerns and the site was clean and orderly.
