4. Details of our assessment

Refresco Drinks UK Limited have stopped production at the site and are in the process of decommissioning.

Officers were met by the Site Lead and discussed the options for permit surrender and permit transfer. The operator has been sent links to the permit surrender guidance on the NRW website. The Site Lead explained that a decision is yet to be made by the operator regarding permit surrender/ permit transfer.

Officers asked the Site Lead to inform NRW of the operator's intentions regarding permit surrender/ transfer as soon as possible, once a decision has been made.

Officers carried out an inspection of the site, accompanied by the Site Lead.

There were no operations taking place, apart from the decommissioning work. Machinery and materials are in the process of being removed from site. There was a small quantity of oils and chemicals stored on site. These were stored appropriately in a bunded area.
