### 4. Details of our assessment

#### Waste Return Review

A review of the waste returns submissions for permit EPR-NB3293HV has been completed

with regard to Condition 4.2.2 of your permit which states 'Within one month of the end of each quarter, the operator shall submit to Natural Resources Wales using the form made available for the purpose, the information specified on the form relating to the site and the waste accepted and removed from it during the previous quarter'. The review found that all waste returns have been submitted up to date.

Action only

Please be aware that waste code 17 05 07, (listed on the returns as none being accepted) relates to track ballast containing hazardous substances, which is not permitted to be accepted under the permit. Track Ballast is listed on the permit but must be non-hazardous (EWC 17 05 08). As the code 17 05 07 was listed as a nil return, a non-compliance score has not been issued.
