4. Details of our assessment

NRW reviewed Pre-Operational Condition Reference 3 of permit Variation BU7766IC/V009NRW issued on the 08/09/20 with comments requiring addressing and re-submission given in CAR_NRW0036959.

The Operator re-submitted the following documents in response:

- Waste Acceptance/Rejection Bryn Posteg Document No. EMS-3-13.01LNF Version 2.3 Received on 10/12/20, and
- Quarterly Returns Document No. EMS-3-LNF Version 2 received 10/12/20 15:01hrs.

NRW approve the procedures for waste acceptance despite noting that some of the comments in the previous review have not been addressed. We understand that the requirement to weigh fines entering the compost operation from the trommel is a process no longer likely to occur. Should such composting of fines be revived further discussions will have to be had.

ACTION: The Operator should provide evidence in accordance with permit requirements that these approved waste acceptance procedures have been implemented in the way of providing appropriate training records in accordance with pre-operational condition reference 4 prior to accepting waste for disposal.

Once you have confirmed pre-operational condition reference 4 is complete please also indicate when you are likely to commence accepting waste for disposal in the landfill.

Advice & Guidance

The Operator is advised to ensure procedures are in place for appropriate characterisation of waste produced at Bryn Posteg. This will be the subject of future inspections.

The Operator is advised that all waste moved between different permits operated by the operator at site or between sites requires procedures for tracking, weighing and recording so that these are accurately recorded in the Quarterly waste returns, i.e. compost pad leachate to landfill permit leachate treatment plant, compost from compost permit to landfill permit for restoration, sludge from leachate treatment plant activity to disposal at landfill.
