4. Details of our assessment

Evaluation of Ambient Bioaerosols at Llanddulas Composting Facility

Bioaerosol monitoring was undertaken in accordance with Condition 3.4.1(b) and Table S4.1 on 6th November 2020.

Table S3.2 specifies limits for bio-aerosol concentrations as follows:

- Total bacteria (TB) - 1000 cfu/m³
- Aspergillus fumigatus (AF) - 500 cfu/m³

Bioaerosol concentrations were below the above limits at three sampling locations - SP1 (upwind), SP2 & SP3 (both downwind) during this monitoring exercise.

SP4 was downwind of turning and material movement operations. The median value for mesophilic bacteria was calculated at less than 83 cfu/m³ and at 3,667 cfu/m³ for aspergillus fumigatus. ***This has been scored a CCS Category 3 breach of Permit.***

Action: Review operational practices on the compost pad and undertake a review of previous results against operational activity highlighting any trends or correlations.

Action: Undertake bioaerosol monitoring during the first quarter of 2021, note any specific operations and deliveries taking place at the time of monitoring.
