4. Details of our assessment

This Compliance Assessment Report follows site inspection at Wrexham Recycling Park undertaken on 10th December 2020 by Julia Frost and Rebecca Harwood.

Following a general discussion around the history of the site the PFI General Manager provided a tour of both facilities, incorporating Phase 1 (In Vessel Composting (IVC), Materials Recycling Facility (MRF) and Transfer Station) and Phase 2 (Mechanical Biological Treatment plant).

Site Visit

At the time of the visit the facility was receiving waste from Wrexham Council. Approximately 60-100t of waste was in the MBT tipping hall.

Buildings are operated under negative pressure. The bioaerosol filters are due to be replaced in early 2021.

All water is collected in sealed drainage and discharged to sewer, except for surface water runoff from the yard.

Processed RDF is taken to an Energy from Waste facility. Around 75% of the tonnage input leaves the site as RDF, the rest is either moisture that has evaporated as part of the process or is additional recyclable material.

Full fire suppression and monitoring is in place. NRW can confirm receipt of the Fire Prevention Plan and confirm that the requirements of Improvement Condition 1 have been met.

The MBT was in operation at the time of the visit and no specific actions relating to its operation were identified.

The Road Sweeping Processing Facility is not currently operational.

Monitoring

Ambient bioaerosol monitoring was being undertaken on site at the time of the visit.

Results from 26th November 2020 were received on 16th December 2020 and were within the ELVs specified in the permit.

Odour monitoring is undertaken from the biofilters. Results from monitoring conducted on 20th November 2020 were received on 11th December 2020. No emission limits are set, however, the results indicated outlet concentrations below 10,000 ouE/s.
