4. Details of our assessment

No issues/ actions following visit:

On 30/11/2020 at 1135 hours Environmental Officers Jenny Rees-Jones and Ryan Carroll met with management the site manager at Maes Mynnan in relation to Abstraction Licence # WA/466/0003/0003, previously #'s 24/66/3/0065 (V002)&[R001]

The Environmental Contact at Breedon was not present at the time of the visit.

Officers went to Maes Mynnan quarry on 30/11/2020 at 1135 hours. The weather at the time of the visit was slightly rainy and overcast. The visit was to conduct an inspection for water resources, dewatering activities and pollution prevention issues in conjunction with a separate waste compliance visit.

Breedon's site at Maes Mynnan was closed for 5 weeks due to Covid-19 between March and May 2020.

Mining activity at the site has greatly reduced and the site is used primarily as a depositing site for inert materials. Any material quarried from Maes Mynnan is taken to Fron Haul to be washed so no abstraction takes place on site from the lagoon.

Site operatives and managers said that they do not abstract from this lagoon as no washing takes place on site and operations are expected to cease there by May 2023.

The last record of abstraction was taken on 31/03/2019 measured at 14425m³ no further abstractions since then.
