4. Details of our assessment**Waste Return Review**

A review of the waste returns submissions for permit DPR-DP3494FN has been completed.

Condition 1.2.1 of the site's permit states 'No wastes other than those, which are categorised below in table 1.2A, shall be accepted at the site'.

Recent Waste Returns such as Quarter 3 2020, show the site has accepted waste coded '170107' which is 'mixtures of concrete, bricks, tiles and ceramics other than those mentioned in 17 01 06'. The site is not authorised by the permit to accept this waste code. Ensure that the site only accepts wastes as stipulated in permit DP3494FN.

It was also noted that Principal TCM Michael Groves Continuing Competency expired on 2/5/2020.

Action Required

Ensure the site only accepts waste codes authorised by permit DP3494FN.
