A review of the waste returns submissions for permit EPR-FB3735AT has been completed. Condition 4.2.2 of your permit requires you to submit within one month of the end of each quarter, a summary of waste quantities and types accepted on to and removed from site for that quarter. Natural Resources Wales have not received any waste returns for Quarter 3 and 4 of 2019 or Quarters 1-3 of 2020.

It was also noted that on previous CAR forms, on the 'site information' tab, details of the site's Technically Competent Manager have been missing.
