4. Details of our assessment

Site inspection following report from a member of the public of pollution entering an ordinary watercourse near the Highwayman Inn. NRW officer attended on the 12th of December, the weather was dry, however there had been rain over the preceding days.

No breaches were observed during the inspection.

Located the sewage treatment system discharge outlet to the rear of the nearby telephone mast, the discharge was clear and there was no smell. There was no evidence of sewage rag or sewage fungus. The ditch was dry despite the recent rainfall and time of the year.

On the day, the site manager, Chris Evans, was unavailable, a member of staff provided contact details.

Chris provided waste transfer notes for the pubs grease traps and sewage treatment system for the past 12 months when requested, via email. The transfer notes show that the systems are being routinely maintained.

Advice

- Potential issues can arise when package treatment plants, which rely on microbial activity to break down waste, do not have sufficient flow of waste, resulting in bacterial populations dying. Extra vigilance should be undertaken following low customer numbers due to coronavirus.
- It is good practice to routinely check the discharge outlet, to identify any problems as soon as possible.
