(b) where the operator's management system encompasses annual improvement targets, a summary report of the previous year's progress against such targets; and

(c) details of any contamination or decontamination of the site which has occurred.

Natural Resources Wales received your 2019 report via email on the 3rd February 2020, as a result the above condition has been breached. A CCS 4 is noted.

ACTION: Please review your environmental management system procedural aspects in regards to reporting to Natural Resources Wales to ensure reports are timely and submitted by the 31 January as required in your permit.

Following my site visit on the 25th November please see below observations:

Waste Transfer notes were checked for several waste streams on site and appeared to be completed correctly.

During the inspection it was noted that some of the external bunds had standing water within them and it was recommended that these were emptied regularly to ensure the effectiveness of the containment of the bund in the event of any spills. You advised that the water within the bunds was tested before discharge.

During the inspection you also advised that the site no longer carried out a number of the activities listed on your permit with NRW and that the remaining activity (production of ferrous sulphamate) is likely to stop in the next couple of years. A discussion was had regarding permit variation or surrender at that time. If you need any more information regarding this, you can visit our website or please contact myself and I can forward you the relevant links and information.

No other issues were noted on site.
