Waste Return Review:

A review of the waste returns submissions for permit EPR-NP3997EE has been completed.

Permit conditions I:1:2 of your permit specifies that a summary of the information, including nil returns shall be submitted for each quarter of the financial year and shall be submitted within one month of the end of each quarter.

Natural Resources Wales has not received any waste returns data for Q2-Q3 2020.

This has subsequently been scored as a C4 breach against the relevant permit condition.

Action Required The missing quarterly returns for 2020 must be submitted to waste.returns@cyfoethnatriolcymru.gov.uk no later than 29th of January 2021 .
