Waste Return Review

(G4) Reporting and notification to Natural Resources Wales

A review of the waste returns submissions for permit EPR-ZB3793HN has been completed.

Condition 7.2.2 of your permit requires you to submit within one month of the end of each quarter, a summary of waste quantities and types accepted on to and removed from site for that quarter.

Natural Resources Wales has not received any waste returns data for Q1-Q4 2019 and Q1-Q3 2020.

This issue was raised on previous CAR forms dated 28th of October 2020 with the action date to submit the missing waste returns - 30th of November 2020 and also on the CAR form dated 11th of May with the action date 1st of June 2020.

This has subsequently been scored as a C4 breach against the relevant permit condition.

Action required The missing quarterly returns for 2019 and 2020 must be submitted to waste.returns@cyfoethnatriolcymru.gov.uk no later than 29th of January 2021 .
