Introductory note

This introductory note does not form a part of the notice

The following notice gives notice of the variation of an environmental permit.

TS Resins Limited have converted a storage tank (T586), that had been previously used to store AdBlue solution, for use as a dedicated on-site storage tank for 33.6% aqueous ammonia solution used to fill the Intermediate Bulk Containers (IBCs). This variation implements the operations occurring under a trial of this technique (under condition 1.5 of the original permit EPR/UP2322IF) that started in May 2020.

Ammonia emissions from the tank are ventilated through a catalytic oxidiser listed as emissions point A7, in the permit EPR/BU2349IL operated by Synthite Limited. Synthite Limited and TS Resins Limited have submitted two letters outlining the agreement between the operators to this arrangement.

The schedules specify the changes made to the original permit.

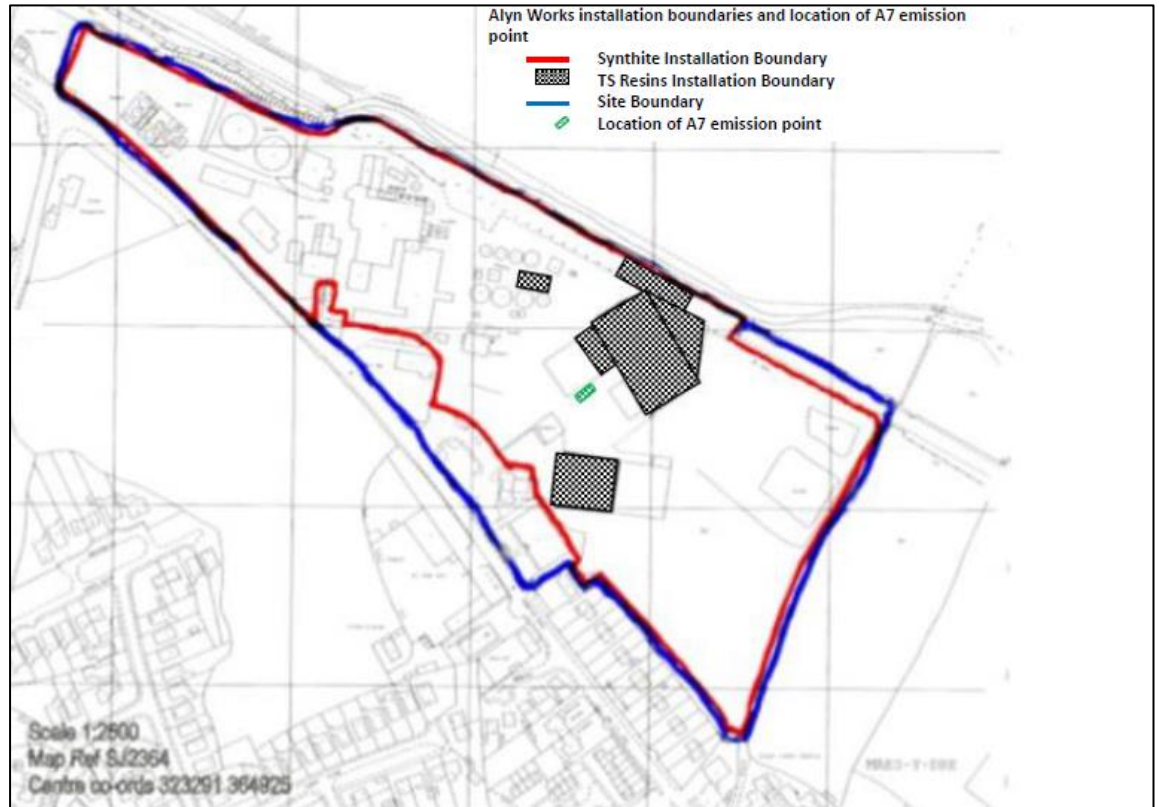
