4. Details of our assessment

A review of the waste returns submissions for permit EPR- DP3294FH has been completed.

It was noted on the Waste Return forms that Gas bottles (160504) were accepted at site in Quarters 1, 2 and 3 of 2020. The total weight of this waste was 1.24 tons. This is in contravention of your permit which does not include the acceptance of these wastes.

It was noted on the Waste Return forms that Rejected Form MRF (191204) were accepted at site in Quarters 1, 2 and 3 of 2020. The total weight of this waste was 9.46 tons. This is in contravention of your permit which does not include the acceptance of these wastes.

It was noted on the Waste Return form for Quarter 2 of 2020 that Domestic Batteries (200133) were received but the listing did not include a weight for this waste.

The above issues have been scored as a single, consolidated C3 breach against the relevant part of the site permit.

Why waste Gas Bottles (160504) were accepted at site.

Why Rejected Form MRF (191204) were accepted at site.

Inform us of the weight of domestic batteries received during Quarter 2 of 2020.

It was noted on the Waste Return forms that "Chemicals" have been received under the EWC Code 20 01 27. Please could you provide us with a more detailed description of this waste in order to confirm whether it is within the permit limits.

It was noted on the Waste Return forms that Tetra Pak waste has been received and was classified under EWC Code 20 01 39 (Plastics). Please could you contact us to discuss the classification of this waste.
