We need more information about your application

Application reference: PAN-011274

Thank you for your application received on 19th August 2020. We need to ask you for some more information before we can do any more work on it.

In the list of permitted waste types in section 6 of the Supporting Information document of your application, you have included the following two waste types:

15 01 10 (Packaging containing residues of or contaminated by hazardous substances) and **15 01 11** (Metallic packaging containing a hazardous solid porous matrix (for example asbestos), including pressure containers)

You have indicated that you will only accept the mirror non-hazardous entries of these waste codes, however these are absolute hazardous wastes for which there are no mirror alternatives. Please can you clarify if you wish to accept hazardous wastes on to the site? If you do, this will affect the installation activity you have applied for and may affect your OPRA score and fee. If the above is a mistake, please can you amend the table and resubmit an updated version.

Additionally, there are numerous waste types in the table for which you have included both the hazardous and non-hazardous mirror entries. For example you have included 19 01 17 (hazardous entry for which you have specified you will only accept the non-hazardous mirror entry). The mirror entry for this waste is 19 01 18, which you have also included in the table. You only need to include the non-hazardous entries in these cases – please can you remove the hazardous entries from the table and re-submit an updated version.

Please reply within 10 working days from the date of this letter. If we don't hear from you we must return your application and fee.


