4. Details of our assessment

On the 1st December 2020 we received a report of noise coming from site. Officer Natalie

Wrangham attended the area in question at approx 13:58 and substantiated the complaint. The reference number for the incident is 2008398. A new regulation 36 notice is due to be issued and the score is therefore being suspended. Scores will remain suspended at the end of the notice period providing the notice is complied with.

F2 - Noise. Category 3 breach. **Score suspended**

3.3.1 Emissions from the activities shall be free from noise and vibration at levels likely to cause pollution outside the site, as perceived by an authorised officer of Natural Resources Wales, unless the operator has used appropriate measures, including, but not limited to, those specified in any approved noise and vibration management plan to prevent or where that is not practicable to minimise the noise and vibration.

At 13:58 the officer visited the track toward Maendy Farm (South West of the site). From here the officer could clearly see and hear site processing activity from project yellow site. The noise was described as moderate and persistent, giving it a 5-6/10 with 10 being noise from standing next to a busy motorway. In line with our guidance the officer has scored this as a category 3 breach at this location. The met office information stated there was a Westerly wind (2-3mph) and it is noted therefore that this location was not directly West of the site.

Action: A regulation 36 notice is due to be issued which will outline actions to be taken.
