4. Details of our assessment

The purpose of this Compliance Assessment Report (CAR) is to record a breach of environmental permit arising from the exceedance of a permitted emission limit.

Condition 3.1.1 of the environmental permit states:

There shall be no point source emissions to water, air or land except from the sources and emission points listed in schedule 4 tables S4.2, S4.3 and S4.4

Condition 3.1.2 of the environmental permit states:

The limits given in that schedule shall not be exceeded.

Table S4.2 of Schedule 4 to the environmental permit is partially reproduced below.

Emissions monitoring data submitted on 27 January 2021 demonstrates that the measured total suspended solid result at D1 on 10 December 2020 was 43.2 mg/l. This is an exceedance of permitted emission limits and represents non-compliance with the environmental permit.

As a result of this non-compliance a CCS Score C3 has been recorded against compliance sub-criteria (E)(3)

Condition 4.3.1 (b) of the environmental permit states:

*The Agency (sic) shall be notified without delay following the detection of:
(b) the breach of a limit specified in the permit.*

Condition 4.3.2 of the environmental permit states:

Any information provided under condition 4.3.1 shall be confirmed by sending the information listed in schedule 6 to this permit within the time period specified in that schedule.

Part A(b) of schedule 6 to the environmental permit requires NRW be notified **within 24 hours of detection** of an exceedance of permitted limit.

The operator notified the regulator of the exceedance of permitted emission limit(s) on 27 January 2021 at 13:14. The exceedance of permitted emission limit(s) was detected on 27 January 2021 at 13:04. Notification of the exceedance of permitted emission limit(s) occurred within 24 hours of detection which represents compliance with the environmental permit.
