The form was received on 14th January 2021. It confirms that the installation continues to comply with the low impact installation criteria.

Form Performance 1, 2020

The form was received on 14th January 2021. A total of 9.15Kg of mercury was recovered from 1,950Kg of mercury-containing waste. This is much more than in 2020 even though the amount of mercury containing-waste was less, inferring that the waste contained a higher proportion of mercury than in the previous year.
