Chris Hanks emailed NRW on the 10/02/2021 to notify that CHP was tested early in 2020. The operator is reminded of the deadline of 31st January annually for monitoring returns and there is an action to submit the CHP monitoring data by 01/03/2021.

This is scored as a non-compliance for the late return of the annual monitoring data.

Action. Send in emission monitoring for the air stack by 01.03.2021

Waste returns for Q2, Q3 and Q4 2020 were received on the 02/02/2021 and are compliant.
