A pre-arranged final site surrender inspection was conducted on September 21, 2018. Karl Lombardi, Natural Resources Wales (NRW) Waste Regulation Officer and Gary Stringer, Sustainability Manager of IGas Energy Plc were present. The weather was rainy, 13°C, with blustery winds from the south west. Mr Stringer confirmed permission to access the property for the inspection had been granted by the land owner.

The purpose of the inspection was to visually confirm the site meets the criteria for a low risk/basic surrender of permit EPR/MB3993HU, to operate a mining waste operation not including a mining waste facility and the site has been returned to a satisfactory state. IGas Energy Development Ltd (formally GP Energy Ltd) are in the process of surrendering the permit as mining operations have not been conducted or intend to be conducted under the current permit.

The site area as detailed in Schedule 7 of the permit was inspected. At the time of inspection, the site appeared as an undisturbed open grass field with established vegetation, several mature trees and bordering hedge rows. No evidence of a mining operation or associated waste was present during the inspection. The site appeared clean, safe and in a satisfactory state with no debris, plant or associated mining machinery observed.

Based on the final site surrender inspection, the permitted site meets the NRW RGN 9 Surrender Guidance in that, ***the site (regulated facility) has been returned to a satisfactory state, having regard to the state of the site before the facility was put into operation.***
