4. Details of our assessment

Self report received by NRW from DCWW on 29/10/2020 stating -

"There was a discharge from site during heavy rain 29/10/2020. Earlier in the day pipework

containing crystallised aluminium sulphate had been removed from the site dosing equipment and placed on a trailer outside for onward disposal. Due to the heavy rain, the crystallised aluminium sulphate deposits were dissolved and washed from the trailer via the on-site settlement lagoon through the OSM discharge point to the Afon Fathew, in excess of the discharge consent"

Sampling at the time of the discharge showed total aluminium at the discharge point to be 22,000µg/l against a permitted total of 8,000 µg/l. Although this is approximately 2.75x greater than the permitted total, it is unlikely that this will have had any considerable impact due to high flows in the river at the time of the discharge, therefore this breach will receive a CCS Category of 3.

Under Non Waste Framework Directive Exemption 3, any waste produced on site can be kept on site, but must be done so in a way that is secure and does not prevent a risk to the environment. In future, please ensure that any contaminated waste is stored within a bunded area, or under cover where there is no foreseeable risk of contaminants being washed off.
