4. Details of our assessment

Site inspection of permitted asset.

Reason for inspection: Routine and because asset discharges to Water Framework Directive watercourse.

Operational Supervisor Lee Banks and Pollution Prevention Technician Sophie Page present.

Weather: Cloudy.

The wet well and the power unit was open for inspection.

The wet well was not full, and pumps were not operating.

The power unit was on.

The emergency overflow within the wet well was observed and not operating. The emergency overflow had a passive screen and appeared to be in an efficient operational condition.

No evidence of a discharge from the emergency overflow was evident from the discharge pipe or in the receiving watercourse.

Telemetry alarms were in place to warn of power failure, pump failure, high levels in the wet well, and discharges from the emergency overflow,

A standby pump that is triggered automatically in the event of failure of the duty pump was present

There was suitable access for a sewage tanker to facilitate emergency removal of sewage and minimise the likelihood of a discharge occurring.

There was suitable access for standby power such as a mobile generator as a minimum.

The asset was secure with steel palisade fencing on all sides.

Whilst on site we ran through a scenario of an electrical failure stopping pumping to the rising main. Satisfactory methods in dealing with this scenario were presented on site.

NB. An audit of data recorded on site and management plan will be conducted in addition to this site inspection. If the data and plan indicates breaches, a further Compliance Assessment Report (CAR) will be submitted to you for comment and actions. This data and plan will be requested separately from this site inspection CAR.

NB. The CAR states the operator is Persimmon Homes. This is an NRW system error as the permit has actually been transferred to DCWW.
