4. Details of our assessment

Natural Resources Wales have received a number of reports of odour emissions from the Rhayader Depot, particularly since July 2020. A significant amount of these reports have occurred on a Saturday or Sunday but not exclusively so. The incident number referred to in the report is the latest incident report received. None of the reports have been substantiated by an NRW Officer.

Liz Park (Waste Regulation Officer) undertook a Compliance Visit specifically to look for any possible causes of odour from Rhayader Depot prior to meeting Councillor Kelvyn Curry and a reporter.

On the day of the visit, the weather was cold with a low cloud and light drizzle.

Liz was accompanied by Ashley Collins (Senior Manager - Waste and Recycling Service), Nigel Hicks (TCM) and Paul McCarley (TCM).

At the time of the visit the reception bay door to the main transfer building was open as mixed municipal waste was being accepted. No odour was noticed in this vicinity. Approximately 60 tonnes of mixed municipal waste were being stored on site. The extraction fans were in operation. Liz walked around the back of the building and a low level localised waste odour was observed in the vicinity of the output from the fans. No odour was noticed in the vicinity of the food waste skip. No odour was noticed outside the shed for the mixed plastic/ cans, paper and card. No odour was noticed in the vicinity of the glass bay.

The meeting with Ashley Collins, Councillor Curry and a reporter was held outside the permit boundary. No odour was noticed. At present, there is no known cause for the odour experienced by the reporter.

Therefore, as there was no odour noticed outside the permit boundary by a NRW Officer there is no breach of permit condition 3.2.1 for odour emissions.

Powys County Council continue to undertake regular checks for odour in accordance with the EP03 – Odour Management Plan. They have previously made additional checks outside normal operating hours and will continue to do so when possible. To date no odour outside the permit boundary has been detected by Powys County Council staff.

Checks will continue to be made by Powys County Council and Natural Resources Wales Officers when in the vicinity. It is accepted that due to the COVID-19 pandemic, Officers are not able to make ad hoc checks as often as they would be able to do under normal circumstances.
