4. Details of our assessment**Waste Return Review**

A review of 2020 waste returns for permit BP3298VK has been completed.

It was noted that waste code 15-01-07 (Waste Glass Packaging) has been accepted to site (In Q1, 2 & 3). This waste code is not authorised by the permit and should not be accepted on site.

This waste stream should be reviewed to ensure it is being coded correctly. Please clarify what this waste is and why it is being accepted to site.

The site's Technically Competent Manager's Continuing Competency expired 07/06/2020. Please send across evidence of the TCM's Continuing Competency or evidence that a course has been booked.

A minor clerical error was picked up on. The 'return period' for Quarter 3 was recorded as 'April -June' rather than July-September.
Please ensure all fields are filled out accurately.
