2. What action is required?

Any non-compliance we have identified and recorded on this form is an offence. It can result in criminal prosecution and/or suspension or revocation of your permit.

At this time, we do not intend to take any further action.

4. Details of our assessment

Forms S1, Emissions to Sewer, 1st January to 31st December 2020; E1, Energy Usage 2020; WU1, Water Usage 2020 and MR1, Mass Releases 2020, were received on 20th January 2021. An amended form R1, Waste Disposal and Recovery 2020, was received on 26th January 2021. Production was more than 30% lower than in 2019. All the reports are accepted.

S1, Emissions to Sewer, 1st January to 31st December 2020

Overall discharge to sewer was less than in 2019 and was about 15% lower per unit of production.

E1, Energy Usage 2020

Overall energy usage was less than in 2019 and was about 7% less per unit of production than in the previous year.

The energy supplier has stated that all electricity supplied to Continental comes from renewable sources. Continental have therefore not been able to provide a value for the CO₂ generated due to their electricity consumption. Some CO₂ will have been generated due to power losses in the transmission system.

R1, Waste Disposal and Recovery 2020

The total amount of waste sent for external treatment or to landfill was considerably more than in 2019 and was more than five times the amount generated per unit of production than in 2019. However, the majority of this waste was recycled, a large proportion of which was either soluble oils or the residue from drain cleaning.

Less filtercake was produced than in previous years, probably because production volumes were low.

WU1, Water Usage 2020

Overall water use was less than in 2019 and decreased by more than 15% per unit of production.

MR1, Mass Releases 2020

Mass releases of cadmium were more than 35% less than in 2019 and mercury releases were 50% less than in 2019. Both are well below the permitted concentrations.

This has been a very difficult year for manufacturing industry and so these reports cannot be taken as representative of Continental's efforts to improve energy efficiency and sustainable use of resources. It was encouraging to see that production levels increased in the last quarter of 2020.
