4. Details of our assessment

Officers had a short meeting with the Site Manager and the Health and Safety Coordinator

who provided an overview of site operations. These members of staff then accompanied officers around the site.

Officers carried out a visual inspection of the feed mill, warehouse and vehicle wash area.

Diesel and AdBlue were stored in above ground double skinned tanks and banded appropriately. This area was covered by CCTV to deter fuel theft.

The duct from press 1, that carries dust to the abatement plant, was replaced in August 2020 due to a deterioration of the plastic joint. This is now inspected annually as part of the site's Planned Preventative Maintenance (PPM).

Following the site inspection, NRW received several incident reports relating to noise nuisance at the site in January 2021.

The operator was made aware of these reports and is currently carrying out an investigation at the site.
