4. Details of our assessment

The Pig & Poultry Certification Body, NSF, carried out an inspection of Maesmawr Hall Poultry Units on 12/01/2021 and their findings have been reported back to us.

- One non-conformance was identified during the inspection: 'On farm incinerator has been changed since 2012 but a current APHA certificate is not available'.
 - We are aware Mr David Kynaston has been in contact with the Animal and Plant Health Agency (APHA) regarding this matter. APHA have confirmed in writing that their records show that the current incinerator has received a satisfactory inspection year on year from APHA inspectors. However, a lead veterinary inspector will need to visit whenever feasible to formally approve certification and ensure the Animal By-Product Incinerator records are current.
 - With the above in mind, we will not record a non-conformance for this finding. Please keep us updated as to when a lead veterinary inspector will be visiting and send the certificate once completed.

- The Certification Body found that the resulting ash from the incinerator is currently being stored on site.
 - For your information, the ash may be used under a U15 waste exemption which allows ash from burning pig and poultry to be mixed with slurry and/or manure, and spread on farmland to provide a nutrient benefit. Please read the exemption carefully to ensure all requirements can be followed prior to registration and use of the exemption: [U15 waste exemption: pig and poultry ash - GOV.UK \(www.gov.uk\)](http://www.gov.uk/guidance/u15-waste-exemption-pig-and-poultry-ash)
 - Alternatively, the ash may be disposed of at a registered waste site which accepts the specific waste code.
