4. Details of our assessment

The Officers met with Bill and Jim Lloyd, the facility owners along with David Barratt a structural engineer. This was the first compliance visit undertaken since the issue of the permit and although there were no outstanding compliance actions, it was necessary to check that the work agreed by the Lloyd's to allow the permit to be issued had been completed.

The site was fully concreted and bunded, including the area between the digestate storage tank and the upper yard and has been finished to a high standard.

The permit is a Standard Rules 2018 No.11 On-farm Anaerobic Digestion plant using farm wastes only. At the time of the compliance visit only crops and water were being digested and you confirmed that there was no intention to accept wastes for digestion at the present time.

Because the materials being accepted at the site are not waste, Natural Resources Wales (NRW) consider that your site is "pre-operational". This means that until you accept waste into your facility the only condition of your permit that you are required to comply with is the submission of quarterly waste returns. This is a requirement whether the site is operational or not and in the case of non (or pre) operational sites, you must submit a "Nil" return.

The failure to submit these returns would be a breach of permit and, as explained during the compliance visit, would be scored in accordance with NRW's Compliance Classification System (CCS) and could affect your annual subsistence fee accordingly.

Although you expressed no interest in accepting waste materials into your facility at present, I appreciate that this is a business and as such, plans can change at very short notice. If, or when, you do decide to accept wastes at the facility that mean the site falls under the controls of your permit, although it is not a requirement of your permit it would be greatly appreciated if you would notify NRW prior to wastes being imported to the site.

Legal status of this report

Your permit is issued to you under the Environmental Permitting Regulations. You have a responsibility to comply with the conditions of your permit and prevent pollution/harm of the environment.
