## 4. Details of our assessment

### Annual performance reporting

Condition 4.2.2 of the permit requires a report on the performance of the activities during the previous year. This was received on the 27th January 2021.

The permitted annual tonnage throughput at the site is 22,500t. In 2019 the permitted annual tonnage was exceeded (23,362t accepted). The Operator stated that a system would be incorporated into the weighbridge software to flag to the site and commercial teams that the maximum permitted tonnage was being reached. Despite this, the annual tonnage was again exceeded in 2020, with 23,763t of waste being accepted and treated.

**The exceedance of the annual permitted tonnage limit is a breach of Condition 2.3.2 and has been scored a CCS4.**

**Action: Ensure that tonnage throughput during 2021 is monitored and managed in accordance with the permit.**

**As a result of lack of appropriate systems being in place to manage the tonnage as previously identified, an additional CCS4 has been applied against Condition 1.1 General Management.**

**Action: Ensure procedures / processes are in place to monitor tonnage and cascade to all relevant operational staff. Please confirm to NRW by 31.03.2021 that this has been completed.**

**Advice and Guidance: Consider submitting a permit variation to increase the tonnage throughput at the facility.**

The annual emissions to air were reviewed in CAR\_NRW0036795.

### Waste Returns

Waste returns for Quarters 1-4 were received within the timescales specified by Condition 4.2.5 and all reported waste types are compliant with Table S2.1 as specified by Condition 2.3.2 of the permit. Nb comments above regarding breach of tonnage quantities.
