4. Details of our assessment

Forms W1, Emissions to Water, 1st July to 31st December 2020; S1, Emissions to Sewer, 1st July to 31st December 2020; WaterUsage1 2020; Energy1 2020 and Performance1 2020, were received on 28th January 2021.

Some of the reporting forms have changed because Newport Wafer Fab (NWF) were issued with a new permit in September 2020, making a comparison with previous years more difficult.

All the reports are accepted.

W1 Emissions to Water, 1st July to 31st December 2020

All parameters are within their respective emission limit values (ELV).

S1 Emissions to Sewer, 1st July to 31st December 2020

There are no ELVs for emissions to sewer. All determinands were at low concentrations.

WaterUsage1 2020

Total use was lower than in 2019, but about 50% higher per m² of silicon production (m² Si).

Energy1 2020

The new permit no longer requires NWF to report CO₂ released due to their energy consumption. They have been operating a combined heat and power unit (CHP) since March 2020, which has resulted in a much higher gas consumption in 2020. It also makes the comparison with electricity use in previous years more difficult. The CHP has generated 14,729MWh of electricity since March. Total energy use was less than in 2019 but more than 50% higher per m² Si.

Electricity use was less than in 2019 and about the same per m² Si.

Gas consumption was higher than in 2019 and about five times more per m² Si.

Oil consumption was also higher than in 2019 and about ten times more per m² Si.

Performance1 2020

Production was more than 35% less than in 2019. This significant reduction in volumes could account for the increases in resource use in 2020, due to the costs of keeping processes running with small production volumes or high start-up costs.

The format of the waste reporting has changed and so only general comparisons can be made.

Total waste and solvent waste generated were less than in 2019, but slightly more per m² Si.

No waste was sent to landfill.

The total waste recycled was less than in 2019, but 9% higher per m² Si.

This has been a very challenging year for manufacturing industry and NWF are to be congratulated on managing to keep some production running. It is not possible to make meaningful comparisons with previous performance due to the unusual circumstances in 2020 and the fact that NWF have a new permit, adding the CHP, which has different reporting requirements.
