4. Details of our assessment

As part of Natural Resources Wales' (NRW) routine assessments for compliance, the continuing competence of the Technically Competent Manager (TCM) at Argoed Farm AD Facility was reviewed.

Permit Breaches:**C1 Staff Competency/Training - Cat 3; Permit Condition 1.1.4**

During this review, it became apparent that Mr Hughes - the site's TCM, was unaware of the requirement for TCMs to undertake the continuing competency test every 2 years. Until NRW contacted Mr Hughes regarding this matter during November and December of 2020 therefore, the site had not been compliant with an approved competence scheme since the 21st of August 2020 - the date at which Mr Hughes' primary competency expired. This is a breach of Argoed Farm's permit conditions and therefore the site has been scored for a category 3 breach. As Mr Hughes registered with WAMITAB to undertake the continuing competence test shortly afterwards however, and provided NRW with evidence of this, this score has been suspended.

Due to COVID-19 restrictions and the closing of Pearson VUE test centres, Mr Hughes' continuing competency test booked for the 6th of January 2021 could not go ahead. NRW regulatory decision statement states that TCMs, whose primary/continuing competency has expired, should look to re-book their test as soon as the test centres re-open. To remain in line with the regulatory decision statement therefore, we ask that Mr Hughes re-book his test at the earliest opportunity once the test centres re-open, and forward NRW a copy of his certificate once complete. A proposed deadline of the 3rd of May 2021 has been set for this. If COVID-19 restrictions prevent Mr Hughes from completing this, we ask that he contact NRW with regard to this matter before the 3rd of May 2021.
