Stack Monitoring delays due to Covid 19.

Due to Covid 19, the stack monitoring scheduled for 26th March 2020 were postponed. Site sent a schedule 5 notification to NRW on 24th March to notify us of the decision.

NRW took a position that we would record missed samples due to Covid 19 as non-compliances, but not apply a penalty score. This is for missing the scheduled monitoring to air from the permitted release points for Q1 due to the imposition of Covid 19 restrictions at the time.

Therefore, we record a noncompliance of permit condition 2.10.1 for not carrying out emissions to air monitoring during Q1 2020. However, this is not scored as a permit breach following the NRW decision.

Annual Returns

All returns were made on time and all permit limits were adhered to throughout 2020.

Pc 4.1.5 EMS Target Review Report.

The gas consumption target of 420 kW/tonne was missed with the site reporting 470kW/tonne for 2020. A new target of 440kW/t has been set for 2021.

The electricity target of 86.8kW/t was missed with a return of 92.3kW/t. The target for 2021 is set at 86.8kW/tonne.

Water use per tonne for 2020 was 0.35m³ against a target of 0.2m³/tonne. The new target is 0.35m³/tonne for any month in 2021.

Oil per tonne figures were 0.96 litres per tonne for 2020 against a target of 0.58l/tonne. The target for next year is set at 0.57l/tonne.

Pc4.1.4 Fugitive emissions review

Main sources were identified within the report. NRW had no complaints made against the permitted site during 2020.
