4. Details of our assessment

Forms S1, Emissions to Sewer, 1st July to 31st December 2020; R1, Waste Disposal and Recovery 2020; E1, Energy Usage 2020 and WU1, Water Usage 2020, were received on 1st February 2021. All the reports are accepted.

S1, Emissions to Sewer, 1st July to 31st December 2020

All parameters were within their respective emission limit values.

There was a decrease in all production of about 15%, compared with 2019, caused mainly by a reduction in zinc and zinc-nickel plated components. This was mitigated by an increase in the production of anodised components.

R1, Energy Usage 2020

Overall energy usage fell slightly and was also lower per unit of production than in 2019. CO₂ generation per unit of production was slightly more than in 2019.

WU1, Water Usage 2020

Water usage has decreased, both overall and per unit of production, compared with 2019. Water consumption has been steadily decreasing since 2016.

R1, Waste Disposal and Recovery 2020

The total amount of waste generated increased slightly compared with 2019 and rose by almost 20% per unit of production. The total amount generated has been increasing since 2016.

The increase in waste generated is in part due to disposal of excess plating solution, which has continued from last year. ZF should investigate ways to reduce this waste stream which should reduce both the volume and cost of its disposal.

This has been a difficult year for all manufacturing industry, with those supplying the automotive sector being particularly badly affected. It is encouraging that the reduction in production volumes at ZF has not been larger. Due to the exceptional situation last year, it would be unfair to comment further on the site's performance during 2020.
