4. Details of our assessment

Compliance Assessment Report

This is a desk-based audit of the 2020 Waste Return submissions for Mr Lee Gapper and Mrs Marie Gapper, ADJ Skip Hire, Unit 3, Graddfa Industrial Estate, Llanbrdach, Caerphilly permit number EPR-JB3033RC conducted by Officer Jonathan LEE.

To remind the operator, following each assessment Natural Resources Wales will produce a Compliance Assessment Report (CAR) detailing our comments from the inspection. If we substantiate reasonably foreseeable risks or actual impact to the environment, we can breach the business against your permit conditions. This can affect your site banding and annual subsistence fees; scored on a Category 1 - 4 basis:

- 1 - Major, serious persistent and/or extensive impact on the environment/people/property
- 2 - Significant impact on effect on the environment/people/property
- 3 - Minor impact or effect on the environment/people/property
- 4 - A non-compliance which has no potential environmental effect

Permit Compliance

G4 – Reporting and notification to Natural Resources Wales – Category 3 Breach

Permit condition 4.2.2. states that *'within one month of end of each quarter, the operator shall submit using the form made available for the purpose, the information specified on the form relating to the site and the waste accepted and removed from it during the previous quarter.'*

The operator has failed to submit its Waste Return documents for **all** quarters in 2020. It is essential to submit your Returns data to NRW on-time to allow us to assess your waste inputs and outputs, even if for a null-return. Operators have a one-month grace period to submit quarterly returns:

In line with our guidance, we may suspend scores for up to six months to allow time for remedial action to be taken. Suspended scores will be re-instated if the action is not completed.
