4. Details of our assessment

The ESH Targets Overview for 2020 was received on 1st February 2021.
The report is accepted.

The reduction in energy use was set at 2%. Energy use per 1000 parts fell by 7.3%.
All energy is now purchased from renewable sources.

The target of reducing water use per 1000 parts was 2% and the actual saving was more than 50%, but the usage data is only available up to the end of September 2020, so the final result may change. One waste target was to increase the amount of recycled waste, as a percentage of total waste, to 95%. This target was not achieved because less metal swarf was sent for recycling in 2020. The actual amount sent for recycling was 91.5%.

The other waste target was to reduce the total amount produced per 1000 parts by 2%. The actual reduction was 23%.

The hazardous materials inventory was reduced by 2.9%, the target being 2%.

It was not possible for Continental to meet several of their targets in 2020 due to the unusual situation. These were to use more returnable packaging and to reduce the amount of wood and cardboard sent for recycling and to reduce transport and traffic.

Continental have postponed their application for the Silver Welsh Corporate Health Award due to the covid situation. They already hold the bronze award.

Continental exceeded most of the targets they set themselves, but were unable to achieve others due to the unusual situation in 2020.
