4. Details of our assessment

On the 10.12.20 Environment officers Rhys Handley and Luke Burton undertook a permit inspection at Amber recycling The Recycling Centre Dyffryn Business Park Ystrad Mynach Caerphilly CF82 7RJ.

During the site inspection no breaches were found. Only advice and guidance regarding the pre population of site inspections, safe storage of Ad-blue and incorrect fire drainage plan. Assurances were provided on site that these matters will be corrected immediately.

A water quality sample of the site's discharge was taken at 12:11 at the allocated sample point at ST 15197 92832 that was appropriately signed and sent to NRW laboratory for analysis.

The results for suspended solids within the sample was 143 mg/l after drying at 105°C

Under permit AN0317001 Condition 6 Composition The discharge shall not contain more than:

- a. 50 milligrams per litre of suspended solids (measured after drying at 105°C)

As this is almost three times the permitted discharge actions will be required to review and improve the discharge effluent.

- Investigation into the maintenance and effectiveness of the site's interceptors – In line with [‘Use and design of oil separators in surface water drainage systems: PPG 3’](#) guidance
- CCTV survey of site drainage to ensure that all components are working correctly
- Review of site works that can cause an increase of suspended solids
- Submission of an action plan documenting the results of the above investigation, survey and review, including actions to address issues established and timescales for completion of those actions, for NRW approval
