Compliance Assessment Report

This is a desk-based audit of the 2020 Waste Return submission Mrs Kayleigh Parsons, RDA Recycling, Yard 3, Commercial Lane, Risca, Newport permit number EPR-NP3895FH by Officer Jonathan LEE.

To remind the operator, following each assessment Natural Resources Wales will produce a Compliance Assessment Report (CAR) detailing our comments from the inspection. If we substantiate reasonably foreseeable risks or actual impact to the environment, we can breach the business against your permit conditions. This can affect your site banding and annual subsistence fees; scored on a Category 1 - 4 basis:

- 1 - Major, serious persistent and/or extensive impact on the environment/people/property
- 2 - Significant impact on effect on the environment/people/property
- 3 - Minor impact or effect on the environment/people/property
- 4 - A non-compliance which has no potential environmental effect

Permit Compliance

G4 – Reporting and notification to Natural Resources Wales – Category 3 Breach

Permit condition 6.1.2 states that *‘A summary record of the waste types and quantities accepted and removed from the site shall be made annually at the end of each year and shall be submitted to the Agency within one month of the end of that year. The summary record shall be in the format detailed in Appendix A or otherwise subsequently agreed with the Agency in writing.’*

The operator has failed to submit its annual Waste Return documents for 2020. It is essential to submit your Returns data to NRW on-time to allow us to assess your waste inputs and outputs, even if for a null-return. Operators have a one-month grace period to submit annual returns, returns are required to be submitted by the 31st January.

Action

Please submit your all outstanding Waste Returns documents to NRW for review by 1 March 2021.
