4. Details of our assessment

Tata submitted a Schedule 1 Notification Part A on 29th December 2020 followed by a Part B Notification on 4th January 2021 for an exceedance of the W1 limit, the details are summarised below;

The Part A and B Notification were for suspended solids exceedances at W1 on 23rd and 24th December 2020, reported values of 210 and 110 mg/l respectively. The limit value is

100 mg/l.

The cause of the exceedance was considered to be the very high rainfall over the period. This had necessitated much higher water volumes than usual being pumped to the discharge point. Despite that the settlement lagoon had recently been desilted (completion of Action 1 on CAR_0036947 dated 2nd September 2020) such high water volumes most likely led to suspended solids entrainment causing the reported values above the discharge limit.

In view that; Tata Llanwern had correctly maintained the settlement lagoon, that the unusually high rainfall was outside Tata's control, that there is nil environmental impact from the discharge of surface water with a raised suspended solids level particularly when the receiving water already has inherently high suspended solids, on this occasion a permit non-compliance has not been recorded.
