4. Details of our assessment

On 26th November 2020 Ffion Quan carried out a review of the waste returns submitted by the site for the period covering 1st July 2019 to 30th June 2020 as a part of NRW's routine assessments for compliance.

G4 Reporting and notification to Natural Resources Wales – Cat 4; Permit Condition 7.2.2:

You have been given this category 4 breach under the above condition because during the review of your waste returns it identified that you have incorrectly recorded that you accepted EWC code 200303 highways road sweeping on your waste returns. This EWC code should not be reported on your waste returns as it is not entering your permitted facility.

The information reported on Waste Returns is used by Welsh and UK Governments for reporting waste targets and to determine waste policy. Therefore, it is important that the data you report is correct and reflects the waste activities being carried out at your site.

Other than the above matter, the waste returns indicated that all other wastes accepted are under the permit and the amounts accepted are within permitted limits.

Action Required - Re submit all waste returns for the period Q3 2019 - Q2 2020 without EWC code 200303 highways road sweeping by 31/3/21 and continue to submit all waste returns by the expected deadlines.

In this document 'Natural Resources Wales' means the Natural Resources Body for Wales established by Article 3 of the Natural Resources Body for Wales (Establishment) order 2012.
