4. Details of our assessment

The purpose of this Compliance Assessment Report (CAR) is to record Natural Resources Wales' (hereafter NRW) assessment against IQE (Europe) Ltd (hereafter IQE) air returns for June to December 2020 and the annual reporting for 2020.

The following returns have been received by NRW.

Form A1

- For the period 01/07/2020 to 31/12/2020 all substances measured were well within the ELVs that are required in the permit.

Form E1

- For 2020 the sites energy usage has decreased, although the CO2 per unit has increased to 0.0061g

Form W1

- The total water used at the site has increased by 14% from last year to 2608m3

Form R1

- The waste per unit has increased for a second year to 0.0009g from 0.0007g in 2019.
- 91.5% of the non-hazardous wastes on site have been diverted for re-use or recycling with the remaining being disposed to landfill.
- 90% of the waste on site has been diverted for re-use or recycled while the remaining 10% has been used at a waste to energy facility.

IQE Europe Performance Review

Performance review compliant with permit condition 4.2.2. The annual amount of total raw ammonia used was up from 0.51 tonnes in 2019 to 0.69 tonnes in 2020.
