4. Details of our assessment

On 9th December 2020 Ffion Quan carried out a review of the waste returns submitted by the site for the period covering 1st October 2019 to 30th September 2020 as a part of

NRW's routine assessments for compliance.

During the review of the waste returns we identified that waste being removed from the site was considerably lower than the waste being accepted. You have explained this is because the waste meets the standard of PAS100 therefore classed as non-waste. Due to this, we do not expect the same amount leaving the site as what was accepted. This also applies to the deposit element of the site.

Further compliance work will be undertaken for this site in the future.

Other than the above query, the review identified all returns we're submitted, all wastes accepted are allowed under the permit and the amounts accepted are within permitted limits.
