4. Details of our assessment

On 1st December 2020 Ffion Quan carried out a review of the waste returns submitted by the site for the period covering 1st July 2019 to 30th June 2020 as a part of NRW's routine assessments for compliance.

You have been given this category 4 breach under the above condition because during the review of the waste returns it identified possible issues with the coding of wastes. Due to the issues arising from this it has been decided that a site officer will contact you directly and discuss these in person.

In line with our guidance, we may suspend scores for up to six months to allow time for remedial action to be taken. Suspended scores will be re-instated if the action is not completed.
